



**Space Explorers: The Infinite Experience**  
**Release for minor between the ages of 8 and 12**

Infinity Experiences Inc. (the “**Producer**”) presents the exhibition THE INFINITE (the “**Exhibition**”) at the facilities of The Raymond F. Kravis Center for the Performing Arts, Inc. (the “**Presenter**”) located at 701 Okeechobee Blvd., West Palm Beach, FL 33401. This release is to be signed as a parent or guardian of a minor between the ages of 8 and 12 (referred to in the text as “**I**”, or the “**Guardian**”), in order to allow the minor (the “**Minor**”) to participate in the Exhibition with a virtual reality (“**VR**”) headset. The Guardian, undersigned, agrees as follows:

**1. VR Activities.** I have read the warning from headset manufacturer META that allows VR headsets to be worn by people 13 years of age and older. I am aware of the risks associated with wearing VR headsets, including, but not limited to, effects on vision and balance, nausea, orientation problems, the possibility of falling, dizziness, vertigo, seizures, discomfort, headaches, pain or anxiety. I fully understand these risks and that by allowing the Minor to voluntarily participate in the Exhibition and utilize the VR headset, I am doing so at my and their own risk. I further specifically assume, on behalf of myself and the Minor, all risks of malfunction of or defects in the VR headset and associated equipment.

**2. Acknowledgement of Risk.** By signing this acknowledgement, I recognize and accept, on behalf of myself and the Minor:

- a. the known and unknown risks related to the Minor’s participation in the Exhibition inherent to wearing a VR headset regardless of whether all the risks are foreseeable.
- b. The risk of Covid-19 and other contamination.

**3. Authorization.** I am over the age of eighteen (18) and am the parent or guardian of the Minor who I hereby warrant and represent is aged between 8 and 12 years. I have no knowledge of any physical, emotional, or other condition that would be a danger to the Minor. I understand that the Minor and I are responsible for reading, understanding, and complying with all instructions both written and oral, in connection with the Minor’s use of the VR headset. I agree to comply, and to cause the minor to comply, with all health and safety laws, rules, and guidelines issued by the government in relation to Covid-19 and to follow all other instructions and sanitation measures in place. I authorize the Minor’s participation in the Exhibition in an enlightened and informed manner with full knowledge of the potential risks.

**4. Exemption.** Consequently, to the extent permitted by law, I agree, on behalf of myself and the Minor, to unconditionally and irrevocably release, discharge and hold harmless the VR headset manufacturer META, the Producer, the Presenter, their shareholders, affiliates, members, employees, agents, directors, officers, representatives, and partners, and the successors, heirs and assigns of each of the foregoing (the “**Releasees**”) from any and all claims of any kind, including without limitation, actions, suits, procedures, costs, expenses, damages and liabilities, whether known or unknown and whether arising from negligence or otherwise, that may arise out of or in connection with the Minor’s participation in the Exhibition or use of the VR headset. I acknowledge and agree that, on behalf of myself and the Minor, I and the Minor are each releasing any and all right to make a claim or file a lawsuit against any of the Releasees as specified above.

**5. General.** This waiver shall be governed by the laws of the State of Florida and the parties irrevocably consent to the exclusive jurisdiction of the Federal and State courts located in Palm Beach County. I understand that this waiver is intended to be as broad and inclusive as permitted by Florida law. If any provision of this waiver is held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the remaining provisions of the waiver, which are hereby declared severable. This waiver constitutes the entire agreement, written or oral, between the parties with respect to its subject matter and may not be amended except by a written agreement executed by an authorized representative of the Producer and Presenter.

I am the parent/guardian of the Minor. I have read and understand this agreement and agree to its terms.
